Business Manager's Notes

- There will not be an increase in H&W for the Alt Plan and Single Alt Plan.
- There will be a \$0.25 increase in H&W for the Base Plan effective June 1, 2024.
- H&W Trustees voted to allow contributions to the HRA to be based on hours paid instead of strictly 160 hours, with the minimum being 160 hours. (Reporting on hours paid will not be mandatory for all employers, however, employers choosing to make HRA contributions on hours paid must be done on all non-bargaining employees.)
- Trustees voted to allow non-bargaining unit employees to participate in HRA even if the local does not participate in HRA, with a rate not to exceed the highest rate of HRA in the Fund.
- Under the prescription drug benefit, voted to exclude Humira, Skyrizi, and Rinvoq effective 8/1/24. There will be an appeal process with this exclusion to allow covered persons to receive these drugs based on Medical Necessity.
- Trustees voted to adopt the proposal of the Hartford for the Medicare Supplement for retirees and spouses whose providers leave the Medicare Advantage (Humana) network and meet certain criteria.
- Voted to remove the allowance for special education for diabetic and cardiac patients and to exclude all education unless otherwise allowed under the Plan. (Diabetic and cardiac related education will still be covered under nutritional counseling.)
- Voted to grant hour-for-hour credit for contributions based on the participant's home local's CBA plan type when working within a different local within the Fund's jurisdiction which has a different plan type in their CBA.
- Under the Plan's Retiree Opt-In/Opt-Out program, voted to allow a retiree to Opt-Out for any coverage (not just for spouse's employers plans or governmental inspectors). This amendment is effective 4/26/24.
- Voted to adopt an amendment to expand the definition of Prohibited Employment to include non-bargaining employees.
- Voted to keep the Medicare eligible retiree rate at \$666 for 2025.
- Voted to eliminate mailing the IRS tax form 1095B. A notice will be posted in the SPD, Newsletter, and on the Fund's website that a participant can get a copy upon request.
- Voted to eliminate mailing the HRA yearly statements, subject to compliance guidelines. A notice will be posted in the SPD, Newsletter, and on the Fund's website that a participant can get a copy upon request.
- The Pension Fund dropped 1.3% in the fiscal year of 2023. The Pension Trustees agreed the market did not improve enough for any changes to the pension fund so there will not be a "13th Check" for retirees yet or additional credit for non-credited funds.

County Run Solar Project

MOU Between I.B.E.W. Local Union 725 & I.B.E.W. Local Union 146

Registration procedures are to be determined by the applicable Local Union's policies.

Calls for manpower will be put in to and dispatched through Local 725. These calls will be recorded on Local 725's job line daily by 5:00P.M. Eastern Standard Time. You can call the job line from 5:00P.M. Eastern Standard Time until 7:30A.M. Eastern Standard Time the following morning, or until Monday morning if the call is put in on a Friday. Given information will be provided. If there are no calls for manpower, the recording on the job line will reflect it. The job line number is **(812) 877-4239, EXT 3**. For Local 146, extension 3 should only be used when bidding on County Run, extension 4 should be used in order to bid on any other call dispatched through Local 725 as a book II member.

If you are interested in a referral for the County Run job, at the conclusion of the recorded information, state your name, your Local, your original sign date, and a phone number where you can be reached the next morning.

At 7:30 A.M. Eastern Standard Time the following morning, or Monday morning if applicable, the job line will be turned off. The Group I list from Local 725 and Local 146 will be merged into one list. This merged list will be in ranked order according to the date and time in which members signed their respective book. All respondents will be called in order of their rank per the merged list between 8:00 A.M. Eastern Standard Time and 10:00 A.M. Eastern Standard Time. We will call the number that was left on the recorder. If we have to leave a message, or in the case where a message cannot be left, you are required to contact I.B.E.W. Local Union 725 Dispatch within 30 Minutes. If we are not contacted within the allotted 30 minutes, we will move to the next applicant on the merged list.

All respondents who have not been contacted by 10:00 A.M. Eastern Standard Time the following morning can assume that their referral position was not high enough to be issued a referral. Any work calls not filled by 10:00 A.M. Eastern Standard Time will be available at the hall that day. Any unfilled calls can be filled by the first available applicant and the call will remain on the job line until filled.

Referrals will be processed at Local Union 725 and any referral for a Local 146 member will be emailed to Local 146 to be filled out and the copy returned to Local 725. Referrals will be issued at the member's respective Local Union Hall in accordance with the time set forth by that Local Union.
